# MINUTES State GIS Council Meeting

The State GIS Council met Friday, April 2, 2004 at the Oklahoma Water Resources Board Conference Room, in Oklahoma City, OK. ## 4. Approval of March 5<sup>th</sup> Meeting Minutes

Jann Hook made a motion to accept the minutes. Mary Banken seconded the motion. The motion passed unanimously.

#### 5. Discussion and possible action concerning the GIS Council's role in providing information to the Governor and Legislature including, but not limited to, the present structure and funding of the Council and the role it should play in state government

Mike Sharp informed the Council members HB 1877 did not make it out of the Senate committee and is now dead. The bill passed out of the House on March 10, 2004 and was assigned to the Appropriations Committee of the Senate. The author of bill, Senator Price, thought it had been assigned to the Natural Resource Committee. However, it was never assigned and was not heard during the committee meeting. HB 2457, the original bill, which contained language concerning the Conservation Commission and Risk Management, was heard during the Committee meeting. Senator Price, when discussing HB 2457, indicated that he would like to insert some new language into HB 2457, the GIS language. The bill was then sent to a Conference Committee, which is where the original author, Representative Clay Pope, hoped to get the bill originally. Changes to the language can now be made so that all parties involved in the process can be satisfied. Mike Thralls, Executive

The Council members and Mike Thralls held discussion about the committee and the timeframe for creating this new language.

The new NRCS digital orthophotography will hopefully be released soon. There is also a planned 2004 flight for new orthos, which is scheduled to be 2-meter resolution. Mike Sharp stated that the Conservation Commission would be working with NRCS through a partnership agreement to try and acquire the 2003 orthophotography and make it available through Geo Information Systems. Eric Jones from Strategic Consulting International offered to donate funds to the state to help obtain the statewide 2003 DOQs.
