MINUTES State Geographic Information Council Meeting

The State Geographic Information Council met Friday, September 11, 2015 at the Oklahoma Board of Regents Conference Room in Oklahoma City, OK. 7. <u>Discussion and possible vote concerning the proposed FY'17 budget for the Office of</u> <u>Geographic Information. This budget, pursuant to Title 82:1501-205.3.C, will be included in the</u> <u>FY'17 budget request of the Oklahoma Conservation Commission.</u>

The FY'17 budget request for the Office of Geographic Information (OGI) was presented by Mike Sharp. Discussion focused on the importance of submitting a budget in light of the looming state budget crisis predicted for the coming fiscal year. Even though the OGI has never received any state funding since its creation by statute in 2004 all members present expressed the need to submit the budget anyway. The Council felt it was important to send a message to the Governor and Legislature that the development and maintenance of the state's digital infrastructure was critical as more and more decisions were being made based on this information. It is vitally important that this information is accurate, timely and authoritative as it is used to support activities from disaster response to economic development and everything in between. A motion was made by Kim Carter and seconded by Jeremy Planteen to submit the proposed FY'17 budget for the Office of Geographic Information to the Office of Management and Enterprise Services as part of the Oklahoma Conservation Commissions FY'17 budget submittal as required by Title 82:1501-205.3. The motion passed unanimously.
